- 1. Approval of Minutes from 2009 executive committee and general committee meetings in Ybor City, Florida.
 - The 2009 meeting minutes were unanimously approved.

2. Reports

a. Financial report - Angela Herren, Secretary/Treasurer

- Angela Herren reported that the organization is financially healthy with \$55,536.61 total in the treasury. The Oppenheimer account saw a gain of \$17.79 and stands at \$27,016.04. We hold \$30,135.62 in our general accounts.
- The membership count is 146.

b. Report from editor of *The Latin Americanist* – Greg Weeks)

• Greg Weeks reported that <u>The Latin Americanist</u> journal is doing well. Institutional subscriptions are up 121%. There have been 1800 downloads of articles. Blackwell is pleased with the marketing of the journal. 2011 will have a special issue edited by Jurgen Buchenau and Greg Weeks.

c. Report from editor of the **Annals** edition – Greg Crider)

• The <u>Annals</u> is doing well. There have been some technical discussions with Blackwell.

• Steve Morris reported that the website is up, accessible, up to date, and easy to get to. There was discussion about creating Paypal payments for membership through the website. CLAH does this and it costs \$3-4 per transaction.
